केंद्र ने सोमवार को सभी राज्यों और केंद्रशासित प्रदेशों को आतंकवादी समृह 'स्टुडेंट्स इस्लामिक मुवमेंट ऑफ इंडिया' (सिमी) को आतंकवाद
